



Martinborough Village Camping Terms and Conditions of Stay

We ask all guests to behave in a considerate manner at all times. We reserve the right to cancel the tenancy at any time of any person or group who behaves in an objectionable manner or who breaches these conditions of stay or Health & Safety and Fire regulations.

At check in you may be required to provide a good conduct bond equal to \$50 per person staying (refundable on check out). This requirement may be waived at the discretion of management. Staying with us indicates your acceptance of these Terms and Conditions.

Accounts - Accommodation fees are payable on arrival for the full time booked, no refunds for early departures. All chargebacks, extras, incidentals and costs of damage will be added to your account and may be invoiced or charged to your credit card at our discretion. You will also be charged for all collection costs incurred.

Alcohol may only be consumed on your own site. Excessive drinking and parties are not permitted.

Cabins - Do not smoke in the cabins. A minimum \$150 cleaning charge will apply for smoky or excessively dirty rooms. Dish washing is not included in your room rate and charges may apply.

Campervans & Caravans - must have a current electrical warrant of fitness and their own waste water container. Must also be compliant with LPG Standard (NZS 5428:1996).

Check In and Departure Times - Check in is from 1pm and check out is strictly by 10am for all sites and cabins. Charges apply for late check outs.

Children (Under 18's) - must be staying with a parent or legal guardian. Parents / guardians are responsible for the actions of their children. Younger children must be supervised at all times and accompanied by an adult in the communal facilities.

Damage - Cost of damage to property will be recovered.

Facilities and barbecues must be left clean and tidy after use.

Groups of more than 6 people - special conditions and maximum numbers may apply. Please contact the office to discuss.

Noise - We expect silence after 10pm (1am on New Years Eve only) and before 7am. Loud music is not permitted at any time. If you are bothered by noise after 10pm please call 0800 780909 or pick up the handset outside the office. Any callouts after hours for noise or bad behaviour within the park will incur a \$50 fee to each of the offending persons.

Smoking is not permitted in any of the holiday park facility buildings, in the cabins or in the communal outside areas. Please smoke only on your site and dispose of cigarette butts safely and tidily.

Tents - Electricity can only be connected to tents through an approved isolating transformer or RCD Safety Switch, a power lead can be hired from the office.

Vehicles must be registered at the office before entering the campground and parked on your site or as directed by staff. Unregistered vehicles will be removed. Speed is strictly walking pace only (5kph).

Visitors - A maximum of 4 visitors per site are allowed at the discretion of management, charges may apply. All visitors must sign in at the office on arrival, park in the visitor parking or outside the holiday park and leave by 9pm. Guests are responsible for the actions of their visitors.

Instructions given by Martinborough Village Camping staff and management must be followed.

I agree to the Martinborough Village Camping terms and conditions of stay. I understand that a breach of these terms and conditions may result in forfeiture of my bond. I also understand that serious or repeated breaches may result in cancellation of the remainder of my stay, without refund.
